# 4. Conduct of Anti-Ragging Workshops and Sensitization Programmes


Regular workshops, seminars, and awareness sessions shall be conducted for students, faculty, and staff to emphasize the legal, social, and academic implications of ragging.

## 6. Student Interaction and Counselling Mechanisms

Regular interaction, mentoring, and counselling sessions shall be conducted with students, particularly fresher's, to provide psychological support and to create an inclusive and secure environment.

#### 9. Surprise Inspections

The Institution shall conduct surprise inspections of hostels, student accommodations, canteens, rest areas, washrooms and other relevant locations to prevent and curb any form of ragging or undesirable behaviour.

"Any act of physical or mental abuse (including bullying and exclusion) targeted at another student (fresher or otherwise) on the ground of color, race, religion, caste, ethnicity, gender (including transgender), sexual orientation, appearance, nationality, regional origins, linguistic identity, place of birth, place of residence, or economic background."
