Dr. D. Y. Patil Centre for Management and Research (DYPCMR) facilitates various scholarship schemes provided by the Government of India and the Government of Maharashtra. Eligible students can apply for these schemes via the MahaDBT (Maharashtra Direct Benefit Transfer) Portal.

## **1. Directorate of Technical Education (DTE)**

- **Dr. Panjabrao Deshmukh Vasatigruh Nirvah Bhatta Yojna:** Provides a hostel maintenance allowance (up to ₹30,000 for 10 months) to students from economically weaker sections (EWS) whose parents are registered laborers or marginal farmers.
- **Rajarshi Chhatrapati Shahu Maharaj Shikshan Shulkh Shishyavrutti Yojna (EBC):** Offers a 50% tuition fee waiver to students in the "Open" category with an annual family income of up to ₹8 lakh.
- **Minority Scholarship:** Provides financial assistance to students from minority communities (Muslim, Buddhist, Christian, Sikh, Parsi, Jain, and Jewish) pursuing higher and professional courses.

## **2. OBC, SEBC, VJNT & SBC Welfare Department**

These schemes offer tuition and examination fee reimbursements based on the student's category:

- **OBC Students:** Up to 50% tuition fee waiver.
- **VJNT and SBC Students:** Up to 100% tuition fee waiver.

## **3. Social Justice and Special Assistance Department**

- **Government of India Post-Matric Scholarship:** Available for students belonging to Scheduled Castes (SC) or Neo-Buddhist categories with an annual family income up to ₹2.5 lakh.
- **Post-Matric Tuition Fee and Examination Fee (Freeship):** Provides fee reimbursement for SC category students whose family income exceeds the scholarship limit.

## **4. Tribal Development Department**

- **Post-Matric Scholarship Scheme (Government of India):** Financial assistance for Scheduled Tribe (ST) students to pursue higher education beyond Class 10.

## Implementation of the Schemes Announced by Government of India

### Department of Technical Education

#### 1. Dr. Panjabrao Deshmukh Vasatigruh Nirvah Bhatta Yojna (DTE)

The Dr. Panjabrao Deshmukh Vasatigruh Nirvah Bhatta Yojna (DTE) is a financial assistance scheme by the **Department of Technical Education**, Government of Maharashtra, designed to provide a hostel maintenance allowance to students from economically weaker backgrounds.

##### Key Features for 2025

- Target Beneficiaries:** Students belonging to EBC, EWS, or SEBC categories pursuing professional technical courses.
- Income Limit:** Annual family income must not exceed **₹8,00,000**.
- Primary Benefit:** Up to **₹30,000 per year** (distributed over 10 months) for hostel and maintenance expenses.
- Hostel Status:** Applicants must be staying in a government hostel, private hostel, or as a paying guest/tenant.

The institute has successfully processed and approved the following for the current cycle. 62 students have been verified and approved by the institute for the hostel subsistence allowance.

#### 2. Rajarshi Chhatrapati Shahu Maharaj Shikshan Shulkh

##### Shishyavrutti Yojna (EBC)

The Rajarshi Chhatrapati Shahu Maharaj Shikshan Shulkh Shishyavrutti Yojna (EBC) is a significant scholarship program by the Government of Maharashtra designed to provide financial assistance to students from Economically Backward Classes (EBC), Economically Weaker Sections

(EWS), and SEBC categories. The scheme helps students pursue professional and technical courses by reimbursing their tuition and examination fees.

#### **Scheme Objectives & Benefits**

- Objective:** To offer financial support and encourage students from economically disadvantaged backgrounds to pursue higher education in diploma, degree, and postgraduate technical and professional courses.
- Tuition and Exam Fee Reimbursement:** Eligible students can receive up to 100% coverage of their tuition and exam fees.
- Female Student Benefit:** From the academic year 2024–25, 100% of both tuition and exam fees is provided to female students.

### **3. Scholarship for students of minority communities pursuing Higher and Professional courses (DTE)**

Scholarship for students of minority communities pursuing Higher and Professional courses (DTE)" is a financial aid scheme by Maharashtra's Minority Development Department, Government of Maharashtra to help Muslim, Buddhist, Christian, Sikh, Parsi, Jain, & Jewish students with tuition & exam fees for technical/professional courses, with family income up to ₹8 lakhs.

#### **Key Aspects of the Scheme:**

- Objective:** Provide financial support for professional/technical education.
- Beneficiaries:** Students from minority communities (Muslim, Buddhist, Christian, Sikh, Parsi, Jain, Jewish).
- Eligibility:** Maharashtra Domicile, SSC passed from Maharashtra, admitted through CAP/Institute Level, not availing other scholarships.



- Income Limit:** Family income up to ₹8 Lakhs per annum (for Part-1 technical courses).
- Benefit:** Up to ₹50,000/year (actual fees/exam fees, whichever is less) for technical courses (DTE).
- Platform:** Applied through the MahaDBT portal.
