Dr. Dhananjay Patil signed this document on be-half of Chetna Hospital as First Party and Dr. Sunil Dhanawade, Director, DYPGMR signed on behalf of Institute as Second Party.

TERM


The parties agree that this contract shall be for a period of five years effective from 1st May,2022 the date of execution . Each party has the right to terminate this contract without cause with a minimum of 30 days written notice prior to termination.

SCOPE OF WORK FOR CHETNA HOSPITAL :-

1. Tie up for for Providing First Aid, Medical And Counselling facility. Chetna Hospital will provide First Aid and Counselling facility when needed.
2. Chetna Hospital will provide equipped free ambulance as and when needed for emergency patients (subject to availability).
3. Chetna Hospital will conduct free health talks by various specialties and organize periodical health checkup (Height, Weight, BP, Pulse, and General Examination) camps on discounted rates once in a year at institute premises on request of second party, request to be received 30 days in advance.

SERVICE:-

- o Kindly go through the services and charges applicable before admission from front desk or admission desk to settle bill on final discharge without any confusion.
- o The consent once accepted after all queries will be final in all respect of financial settlements, without any mis-understanding.
- o In any special case the issues can be settled on one to one basis if required.

- **CHETNA HOSPITAL WILL GIVE PRIVELEGE OF:-**

- o Priority in admission to ICU or wards for Institute Students and Staff in minimum possible time.
- o Cashless Facility for in-patients: Bills can be paid for cash patient later by institute(on written confirmation by mail) as pre-agreed rates for cash treatment.
- o Facility to pay bills by cash / cheque / internet banking / credit card as perchoice.

- **Institute**

Agrees to co-ordinate with doctors of Chetna Hospital and follow their advice, however the choice of hospitalization and right to choose treatments will still lie with the students of the institute.

- **TERMINATION:**

1. If institute wishes to change or discontinue services, institute may then terminate this contract within further obligation to Chetna Hospital except for services rendered prior to the date of TerminationNotice.
2. Hospital can also terminate / withdrawal discounted benefits if payment is delayed beyond the agreed period of 30 days with no confirmation or reasons for delay.
